Challenges

Improving process efficiency to handle increased sales volume

As a consumer packaged goods producer and marketer of sweetened condensed milk, evaporated milk, bagged popcorn and meal solutions, Eagle Family Foods Group understands the importance of quality, efficiency and consistency. So after acquiring the Hamburger Helper and Suddenly Salad brands in 2022, the company knew it needed to shore up its internal accounts receivable (AR) process to help manage the significant growth in sales volume.

Even before the acquisition, manual processes were causing several challenges for Eagle Family Foods Group — particularly within cash application and deductions management. For example, cash application was a time-consuming, multi-day process largely due to complex remits from the company's largest customer. Deductions was similarly inefficient, with approval done through emails and approval status and customer repayments not easily obtained.

Fortunately, Eagle Family Foods Group was already well acquainted with the benefits of Al-driven automation after implementing Esker Accounts Payable in 2020. So it was a natural next step to expand their automation efforts to their cash application and claims processes.

Objectives

Phase 1: Cash application

- Manage growth without drastically increasing headcount
- Reduce manual work in processing lines from remittance advices
- Quickly post \$0 payments

Phase 2: Deductions management

- Easily track the status of deductions
- Bring all backup documentation into the cloud
- Improve reporting on customer repayments

Solution

Increasing speed, accuracy & visibility with Aldriven automation

Based on its successes with Esker Accounts Payable, Eagle Family Foods Group felt confident in Esker's ability to automate its cash application and claims functions with Al-powered data capture, a simple user interface and customizable workflows.

With Esker Accounts Payable, the company achieved full automation, including 2-way matching with their ERP system for PO and non-PO invoices as well as automated approval workflows. This enabled them to process, on average, more than 2,000 invoices with payments of over \$40 million every month while eliminating paper storage, capturing more early payment discounts and getting real-time performance analytics.

Eagle Family Foods Group was eager to achieve similar performance improvements on the AR side.

Phase 1: Cash application

The company chose to tackle its cash application process first. Prior to Esker, it took up to 2 days to post one day of cash, and the team had to work holidays to keep from falling even further behind. Part of the problem was that it took a huge effort to apply cash from the company's largest client. With 2,000–3,000 lines on the customer's remittance advices that had to be manipulated in Excel prior to posting, it could take the team more than 8 hours to post everything to its ERP.

Today, using Esker Cash Application, all prior day's cash is posted by 2:00 p.m., \$0 checks are posted quickly and the team no longer has to work holidays. It now only takes 5–10 minutes to process its largest customer's remittance advices, thanks to Esker Synergy Al's ability to automatically "read" data from even complex remittances. Additionally, Esker's powerful tracking capabilities allow Eagle Family Foods Group to see which customers are still paying by check so they can encourage them to change to ACH payments for faster processing.

Phase 2: Deduction management

The second phase of the company's automation initiative focused on deductions management. Previously, deduction approvals were handled through email, and backup documentation was stored in various formats and scattered across personal drives. As a result, tracking the status of deductions and pulling together reporting was a challenge — not to mention trying to obtain customer repayments.

With Esker Deductions Management, the entire process occurs within the platform, providing real-time visibility into deductions and ensuring backup documentation is stored in the cloud. All approvals, notes, internal conversations and customer communications are stored with the corresponding claim, allowing all stakeholders to see updates and the claim's current status. Esker Synergy Al pre-populates claim-line information, saving the team time and speeding up the claim process. In addition, Esker's tracking and analytics functionality mean customer repayment information is now reportable.
