

# **Challenges**

### Manual invoice approvals causing delays

With over 120 offices and a team of more than 12,000 specialists worldwide, Brunel delivers skilled talent and workforce solutions to over 45 countries. Brunel specialises in transforming global projects in industries such as Life Sciences, Renewable Energy, Oil and Gas, Infrastructure, Future Mobility and Mining.

Brunel Energy USA faced significant inefficiencies in their accounts payable process, primarily due to their reliance on manual systems. Invoices were managed through emailbased approval workflows, which often resulted in lost or delayed emails, overlooked approvals and substantial frustration across departments. The manual entry of invoices added to the errors, leading to reconciliation challenges and disputes with vendors. Limited visibility into invoice statuses further compounded these issues, as the Finance team frequently found themselves answering vendor queries without adequate data at hand. Mr. Eduardo Villa, Accountant at Brunel Energy USA, explained how this environment made it difficult to ensure accuracy or efficiency in their financial operations.

The goal for Brunel Energy USA was to implement a solution that offered real-time insights into invoice statuses, enabling the accounts payable (AP) team to address supplier inquiries more promptly, reduce frustrations, boost efficiency, and speed up invoice processing.

### **Accelerating efficiency with automation**




